
M/s Attar Logistics Pvt. Ltd., SCO no. 26-27, IInd Floor, Opp. Hotel Ramada, Chandigarh, Ambala Road, Zirakpur, Sas Nagar, Punjab- 140603, Email- navdeep@attarlogistics.com, M-9796259993 has participated in the tender advertised by Central Medical Services Society (CMSS) vide Tender Ref no. CMSS/LSC/CHANDIGARH/2020/07, dated 8th September 2020 for the Empanelment of transport/logistics service provider for distribution of drugs and other health sector goods for a period of one year from CMSS Chandigarh warehouse and was issued a Letter of Acceptance vide no. CMSS/LSC/Transportation Tender/062/667, Dated: - 18th November 2020 for the same.

In view of above, M/s Attar Logistics Pvt. Ltd has replied via email dated 26th December 2020 that, "It was supposed to have transportation services allotment for all destinations instead of considering us only for single destination services as the rates were quoted according to that only. Serving for the single destination is not viable for us hence we would like to proceed with the cancellation of our service request and reimbursement of the advance deposited to CMSS@10,000/-." CMSS has again requested via email dated 28th December 2020 & 20th January 2021 to deposit the performance security and signing the contract agreement, but till date M/s Attar Logistics Pvt. Ltd has not submitted the performance security and also not sign the contract agreement for the letter of acceptance vide no. CMSS/LSC/Transportation Tender/062/667, Dated: - 18th November 2020 issued by CMSS.

CMSS has further send a last intimation letter on dated 19th March 2021 to M/s Attar Logistics Pvt. Ltd for debarring their firm & forfeit their EMD. But, M/s Attar Logistics Pvt. Ltd has not submitted the performance security till date. Clause no. 10 under the section of Earnest Money/Performance Security of the referred bid document states that "Successful bidder should furnish a Demand Draft of Rs. 50,000/- (Rupees Fifty Thousand only) in favour of Central Medical Services Society, payable at New Delhi as Performance Security Deposit. In case Transporter fails to submit the Demand Draft, the EMD submitted by the respective bidder will be forfeited and deemed- fit action shall be taken against the transporter including black listing."

Therefore, it is found that M/s Attar Logistics Pvt. Ltd has violated the terms & conditions of tender document. Hence, as per Letter of Acceptance clause no. 3 & 4 read with tender clause no. 10 under the section of Earnest Money/Performance Security of Tender Ref no. CMSS/LSC/CHANDIGARH/2020/07, M/s Attar Logistics Pvt. Ltd., SCO no. 26-27, IInd Floor, Opp. Hotel Ramada, Chandigarh, Ambala Road, Zirakpur, Sas Nagar, Punjab- 140603, Email- navdeep@attarlogistics.com, M-9796259993 is hereby debarred for a period of 1 year from the date of issue of this order.

The transporter has submitted their EMD of Rs. 10,000 (DD no. 008132, dated 28/09/2020 of HDFC Bank) during tender participation, which is forfeited by CMSS. Further, the transporter shall not be allowed to participate in the tender process of Central Medical Services Society (CMSS) in the future for a period of 1 year from the date of issue of this order.
